Recommendation

It is recommended that the Governing Board accept the Intergovernmental Agreement (IGA) between the Maricopa County Community College District (MCCCD) and the Maricopa County Department of Public Health, Maricopa County Tobacco Use Prevention Program (MACTUPP) in the amount of \$35,620 for IGNITE Program tobacco prevention activities.

Justification

The Intergovernmental Agreement provides grant funding from the Maricopa County Department of Public Health to provide a tobacco prevention program that includes activities on seven MCCCD college campuses and at high schools in Maricopa County. Project activities will include one college campus promotional event at each of the seven participating colleges, the development of campus Student Promotion Teams and College Tobacco Taskforces, attendance at MACTUPP program meetings, participation of one Faculty/Advisor and as many students as possible in the Bacchus Network National Tobacco Symposium on Young Adults, making high school tobacco prevention presentations, and conducting student surveys.

Funds through this Intergovernmental Agreement will be provided to seven MCCCD colleges: Chandler-Gilbert Community College, Estrella Mountain Community College, Gateway Community College, Glendale Community College, Mesa Community College, Paradise Valley Community College, and Phoenix College. The program will begin following acceptance by the Governing Board and being signed by MCCCD Legal Counsel. The IGA will conclude May 1, 2009.
