- 5) Clarification regarding the 80 Seat Classroom beginning on Page 27 4100a-1 of the bid documents: As indicated, this room has the ability to be divided into two rooms. Therefore, the Total Equipment Price should include two (2) each of the items listed, EXCEPT FOR items 1) Audio Mixer, and 4) Presentation Matrix Switcher, which will be quantity one (1) each. See AV signal flows for the quantities.

All other provisions of IFB #2944-9 remain unchanged and are to be bid as stated.
